Respondent has filed a Request for Order changing venue of this case to Tentative Ruling: Butte County. By Stipulation and Order the hearing on that Request was continued to this date. The Court has reviewed the Request for Order and the Petitioner's Responsive Declaration filed on October 18, 2021. From the pleadings and recent declarations filed by the parties as well as the evidence presented at the October 18th hearing before this Court on the request to renew the restraining order, it is not disputed that neither party nor the children reside in Plumas County. The Petitioner and the children reside in Butte County and are also attending school there. Pursuant to Code of Civil Procedure §397.5, where both parties and the children have moved from Plumas County post-judgment, this Court can transfer venue to the new county of residence if the ends of justice and the convenience of the parties would be promoted by the change. Currently, there does not appear to any nexus with Plumas County and a transfer to neighboring Butte County does not adversely affect the convenience of the parties at this time. Therefore, the Court intends to grant Respondent's Request and order this case transferred to Butte County. Respondent's counsel shall prepare the proposed Findings and Order After Hearing and pay any fees required to transfer the case to Butte County. Counsel and parties can appear telephonically by CourtCall if requested.
