## Case No. PR20-00044 Conservatorship of B., S.

Tentative Ruling: **Appearance required.** The Court has reviewed the Investigator's Report and the Physician's Declarations and will discuss with counsel whether a hearing is being requested.

## Case No. PR20-00029 Conservatorship of Butts, Mary

Tentative Ruling: **Appearance required.** This conservatorship is on calendar for an annual accounting review. An inventory and appraisal has not been filed to date.

#### Case No. PR11-00031 Conservatorship of Griffith, Nicholas

Tentative Ruling: **Appearance required.** This conservatorship is on calendar for a review hearing and receipt of the Investigator's Report. # Case No. PR21-00041 Conservatorship of Whitman, Patricia

Tentative Ruling: **Appearance required.** This Petition for Appointment of a Probate Conservator was continued to this date for the Investigator's Report. The Court has not received the Report and will discuss the continuance of this matter. All prior temporary orders remain in full force and effect to that date.

# Case No. PR21-00054 Estate of Hubbard, Thomas

Tentative Ruling: **No appearance required.** Notice has been given as required by law and no opposition to the Petition has been filed. The Court grants the Petition for Probate and grants the requested orders. Petitioner's counsel is to submit the proposed Order and the Court will sign it and have it filed in this case.

# Case No. PR12-0016 Guardianship of Beltran, Kayla & Kobe

Tentative Ruling: **No appearance required.** The Court has received and reviewed the Confidential Guardianship Status Reports filed for Kayla and Kobe. The Court finds that Kayla is now 18 years old and her guardianship is terminated by law. As to Kobe, it is in the minor's best interests to continue the guardianship and the next annual review hearing is set for November 14, 2022, at 9:00 a.m. All prior orders remain in full force and effect. The clerk of the court is reminded to send notice to the Guardian one month prior to that date, informing the Guardian of the duty to file a confidential status report prior to the review hearing. The Guardian is to appear by telephone at that time and date by calling 1-877-336-1829 and enter the access code 4023142. The party must then wait on the line and mute their phone until the Court calls their case.

#### Case No. PR21-00047 Guardianship of Ralston, Skylar

Tentative Ruling: **Appearance required.** This guardianship is on calendar for receipt of the Investigator's Report and determination of whether a permanent guardianship is appropriate. The Court Investigator has requested a continuance for preparation of her report. The Court will continue this hearing for receipt of the Investigator's report to January 10, 2022 at 9 a.m. All prior orders in this temporary guardianship will remain in full force and effect to the next hearing date.
