RECORD SEARCH REQUEST
INFORMATION SHEET

- Effective August 6, 2012 **FAXED and OVER THE PHONE** record search requests are **no longer accepted.**
- Typically, a search request is completed in 5 to 7 business days (excluding Holidays, court closure days, and weather providing) from the date the court receives the request.
- **Record search requests must be submitted in writing or in person and must include a self addressed stamped envelope and with \$15.00 fee per search request. A single request can contain multiple names or case numbers. (Request Form - see pg. 2).**

If the search is concluded in 10 minutes or less, the \$15.00 fee will be returned to you.

● **Specify documents to be copied (cost chart provided below):**

- 1.) Charging documents: Complaint/Information/Citation
- 2.) Disposition: Conviction/Plea/waiver
- 3.) Sentencing Order
- 4.) Protective Order
- 5.) Entire File (Excluding documents that cannot be released)
- 6.) PC1203.4/expungement order
- 7.) Other: _____

*The Clerk's office **cannot** provide copies of:*

- *Police/arrest/incident reports*
- *Transcripts*
- *Warrants*
- *Confidential documents*

Costs:

\$15.00 Search Request fee for any search that exceeds 10 minutes- GC70627(c)

\$0.50 Copy fee, **per page**- GC70627(a)

\$25.00 Document certification fee, per document – GC70626(a)(4)

\$15.00 Certified copy of Dissolution of Marriage- GC70674

Make checks payable to Plumas Superior Court, leave amount blank, and note in memo field “not to exceed \$_____” if you are unsure of the total cost.

Payment for copies of requested documents need to be made separate from the \$15.00 research fee.
