Case No. PR16-00016 – Estate of Cross

Tentative Ruling: **Granted.** Petitioner's Petition for Order Confirming Successor Trustee, Alternatively Executor of Pour Over Will and Trust Assets is granted.

Case No. PR16-00003 – Guardianship of Bailey

Tentative Ruling: **Appearance required.** The court has not received the guardianship investigation report.

Case No. PR16-00006- Guardianship of McKay

Tentative Ruling: **Appearance required.** The court has not received the guardianship investigation report.

Case No. CV16-00045 – Petition of Brawley

Tentative Ruling: **Approved.** The court finds that good cause exists to dispense with a personal appearance. The court grants the Petition to Approve Compromise of Disputed Claim.

Tentative Ruling: **Appearance required.** The court has not received the proof of publication. If proof is provided prior to the hearing, the court intends to grant the petition.
