#### **Case No. PR11-00014 – Estate of Wronker**

Tentative Ruling: **Approved.** The court finds that notice has been given as required by law. Petitioner's Amended First and Final Report of Personal Representative and Petition for Final Distribution on Account and for Payment of Compensation for Ordinary Services to Attorney is approved. Petitioner is to prepare the Order.
