#### **Case No. PR14-00029– Estate of Faris**

Tentative Ruling: **Approved.** The court finds that notice has been given as required by law. Petitioner's First and Final Account and Report of Executor and Petition for its Settlement, for Allowance of Compensation to Executor and Attorney for Ordinary Services and for Final Distribution is granted.

#### **Case No. PR12-00004 – Estate of Jacobs**

Tentative Ruling: **Granted.** Petitioner's Petition for Attorney's Fees and Costs is granted. The court notes that no opposition has been filed.

#### **Case No. PR14-00055 – Guardianship of Marquez**

Tentative Ruling: **Appearance required.** The court notes there is no investigator's report in the file.
