If the clerk is not notified of a party's intention to appear, there will be no hearing and the tentative ruling becomes the order of the court.

If you do appear and want the matter reported by an official court reporter in unlimited civil, family law or probate, you must pay the \$30.00 court reporter appearance fee as provided by GC§68086(a)(1)(A) before the hearing begins.

Case No. PR12-00033 – Estate of Clark

Tentative Ruling: **Appearance required.** The court will hear any overbids. If there are none, the court intends to confirm the sale. Petitioner is to prepare the Order.

Case No. PR10-00014 – Estate of Sieh

Tentative Ruling: **Appearance required.** The court notes there is no reappraisal by the probate referee in the file. If the appraisal or reappraisal is filed prior to the hearing, the court will hear any overbids. If the appraisal or reappraisal is not filed, this hearing will be continued to a date requested by the petitioner.

Case No. PR09-00001 – Guardianship of Martin

Tentative Ruling: **Appearance required.** If there is no appearance, the court will dismiss the guardianship.

Case No. PR13-00019 - Guardianship of McKinney, B

Tentative Ruling: **Appearance required.** The court has not received the investigator's report.

Case No. 13-00020 – Matter for McKinney, T & A

Tentative Ruling: **Appearance required.** The court has not received the investigator's report.

Case No. M97-22960 – People vs. Reeves

Tentative Ruling: **Appearance required.**

Case No. CV09-00243 – Owens vs. Kerns

Tentative Ruling: **No appearance required.** At the request of counsel, the Motion to Continue the Trial is continued to July 22, 2013, at 9:30a.m.

Family Law – 10:30 a.m.

Case No. FL12-00195 – Clift vs. Nelson

Tentative Ruling: **No appearance required.** The court notes that respondent has not paid the filing fee, and the returned check fee, for his Request for Order. The court also notes that respondent has failed to participate in court-ordered mediation prior to the hearing. As a result, this matter will not be heard.

Case No. FL09-00202 – Cravens vs. Meza

Tentative Ruling: **Appearance required.** The court will hear the results of mediation. If there is no agreement, the court will order a recommendation.

Case No. FL09-00060 – Mar. of Creasey

Tentative Ruling: **Appearance required.** The court notes there is no proof of service in the file on the petitioner. If petitioner is served and is present, the court will order the parties to mediation.

Case No. FL13-00121 – Handley vs. Widberg

Tentative Ruling: **Appearance required.** The court notes there is no proof of service in the file on the respondent. Although the court has received and signed a custody and visitation agreement, petitioner has also requested child support. The court will require the petitioner to prepare a DissoMaster report for support or contact the Department of Child Support Services in order to have child support determined and ordered.

Case No. FL01-22146 – Mar. of Lamattina

Tentative Ruling: **Granted.** Petitioner's Request to Modify Support is granted, in part. The court has reviewed the Request for Order, the Response, the parties' Income and Expense Declarations and attachments, and finds that due to a change of circumstances, spousal support is modified and reduced to \$100 per month, effective August 1, 2013, until further order of the court.

Case No. FL12-00224 – Mar. of Judd

Tentative Ruling: **Appearance required.** The court will order a recommendation.

Case No. FL03-24282 – Scoppwer vs Wood

Tentative Ruling: **No appearance required.** The court continues the respondent's progress report on probation to July 22, 2013, at 10:30a.m., due to the absence of Judge Hilde. Respondent is ordered to appear at that time.

Case No. FL07-27628 – Scoville vs. Delgado

Tentative Ruling: **Appearance required.** The court will review the recommendation with the parties.

Case No. FL13-00082 – Snyder vs. Moxley

Tentative Ruling: **Appearance required.** The court has not received the recommendation.
