

# **Tentative Rulings**

## **Law & Motion and Family Law Calendar for June 8, 2015**

### **Probate – 9:00 a.m.**

#### **Case No. PR15-00015 – Estate of Axthelm**

Tentative Ruling: **Granted.** The court finds that notice has been given as required by law. Petitioner's Petition for Probate is granted, although the court notes that the attachment appears to be inappropriately labeled as attachment "3(d)(3), f(2)(a)", and should be labeled as attachment 3(d)(2), 3f(1)(c), and 3f(2)(b). Petitioner is to prepare the Order.

#### **Case No. PR13-00028 – Estate of McGushin**

Tentative Ruling: **No appearance is required.** John Schaller's Petition for Attorneys' Fees is continued to June 22, 2015, at 9:00a.m. Judge Hilde is not available on June 8.

#### **Case No. PR06-6295 – Guardianship of Billings**

Tentative Ruling: **No appearance required.** The court has received the reviewed the confidential guardianship status report, and finds that continued guardianship is in the best interests of the minor. As the minor will be 18 years old on June 10, the guardianship will automatically terminate on that date, and the court will not order any additional review hearings.

#### **Case No. PR15-00020 – Estate of Bonnell**

Tentative Ruling: **Granted.** The court finds that notice has been given as required by law. Petitioners' Petition to Determine Succession to Real Property is granted.

## **Civil – 9:30 a.m.**

### **Case No. CV13-00149 – Seneca Gold vs. Preim**

Tentative Ruling: **No appearance required.** The court notes that no demurrer has been filed by the plaintiffs/cross-defendants. The court will hear the case management conference at 2:00p.m., and discuss the proposed stipulation for continuance of the demurrer hearing submitted by the defendant Jon Shields.

### **Case No. CV12-00268 – Warner vs. Randy Hill Construction**

Tentative Ruling: **Granted.** Plaintiff's Motion for Order Deeming Admitted Truth of Facts and Genuineness of Documents, and for Sanctions in the amount of \$330 is granted. The court notes no opposition was filed.

### **Case No. CV15-00062 – Matter of Turner**

Tentative Ruling: **Granted.** The Petition to Compromise Disputed Claim is approved.

## **Family Law – 10:30 a.m.**

### **Case No. FL04-25109 – Mar. of Alexander**

Tentative Ruling: **Appearance required.** The court will discuss summer visitation with the parties.

### **Case No. FL14-00012 - Artaz v. Gilbert**

Tentative Ruling: **Appearance required.** If an agreement is filed prior to the hearing, this matter may be taken off calendar.

### **Case No. FL15-00066 – Cutter vs. Mitchem**

Tentative Ruling: **Appearance required.** The court will order the parties to mediation.

### **Case No. FL14-00192 – Henderson vs. DaVeiga**

Tentative Ruling: **Appearance required.** The court has not received summer vacation proposals, but will discuss the summer visitation with the parties.

### **Case No. FL14-00118 – Moore vs. Woods**

Tentative Ruling: **Appearance required.** The court has received the custody evaluation, and intends to follow the recommendation.

# CASE MANAGEMENT CONFERENCE TENTATIVE RULINGS

## Case No. CV14-00097 – Marler vs. Eastern Plumas Health Care

Tentative Ruling: **Appearance required.** The court will confirm a mediator and date for mediation, and schedule another case management conference following this date to hear the results of mediation.

## Case No. CV13-00149 – Seneca Gold vs. Preim

Tentative Ruling: **Appearance required.** The court will discuss the status of the case with the parties. The court dismisses the order to show cause against defendant Shields, as there was no appearance required on May 11.

## Case No. CV13-00202 – Nichols v. Stark

Tentative Ruling: **Appearance required.** If a settlement or dismissal is filed prior to the hearing, this matter may be taken off calendar.
