#### **Case No. PR16-00005– Estate of Brakeman**

Tentative Ruling: **Appearance required.** The court notes that the Notice of Petition to Administer Estate is incomplete, in that paragraph 10 is blank. In addition, paragraphs 2, 4 and 5 are blank in the attached proof of service. The court also notes there is no proof of publication in the file. Petitioner will need to file an amended Notice of Petition and proof of service.

#### **Case No. PR15-000406 – Guardianship of Castillo**

Tentative Ruling: **No appearance required.** At the request of counsel Yates, this matter is continued to March 28, 2016, at 9:00a.m., for setting of a contested hearing.

#### **Case No. PR15-00030 – Estate of Hurst**

Tentative Ruling: **Approved.** The court finds that notice has been given as required by law. Petitioner's First and Final Report of Administration on Waiver of Account and Petition for Final Distribution, for Allowance of Compensation to Executor and Attorney for Ordinary Services and for Final Distribution is granted.

#### **Case No. PR15-00022 – Estate of Vincent**

Tentative Ruling: **No appearance required.** At the request of petitioner's counsel, this motion is continued to March 28, 2016, at 9:00a.m.

#### **Case No. PR16-00008 – Estate of Weston**

Tentative Ruling: **Appearance required.** The court notes there is no proof of service of the Petition in the file.

**Case No. PR10-00009 – Guardianship of Green**
