Case No. PR16-00018 – Guardianship of Litz

Tentative Ruling: **Appearance required.** The court has not received the investigator's report.

Case No. PR15-00038 – Guardianship of Givens

Tentative Ruling: **No appearance required.** The court has received the confidential guardianship status report, and finds that continued guardianship is in the best interests of the minors. The court schedules the annual review hearing for May 22, 2017, at 9:00a.m. The clerk of the court is reminded to send notice to the guardian one month prior to this date, informing the guardian on the duty to file a confidential status report prior to the review hearing.
