#### **Case No. PR14-00020 – Conservatorship of Quinby**

Tentative Ruling: **No appearance required.** The court has not received the investigator's report. If the report is received prior to the hearing recommending the conservatorship be granted, the court will follow the recommendation. If the report is not received, this matter will be continued to June 9, 2014, at 9:00a.m.

#### **Case No. PR14-00018 – Guardianship of Garcia**

Tentative Ruling: **No appearance required.** The court has not received the investigator's report. If the report is received prior to the hearing recommending the conservatorship be granted, the court will follow the recommendation. If the report is not received, this matter will be continued to June 9, 2014, at 9:00a.m.

#### **Case No. PR11-00005 – Guardianship of Groulx**

Tentative Ruling: **No appearance required.** The court received and reviewed the confidential guardianship status report. It appears the minor has attained the age of majority, and therefore, the guardianship is automatically terminated by operation of law, pursuant to Rule 7.1004(a) of the Rules of Court.
