Case No. PR12-00001 – Conservatorship of Rios

Tentative Ruling: **Appearance required.** The court has not received the investigator's report.

Case No. PR13-00011 – Conservatorship of Thayer

Tentative Ruling: **No appearance required.** This matter is taken off calendar, at the request of counsel, and a Petition to Terminate Conservatorship will be heard on October 28, 2013, at 9:00a.m.

Plaintiff's Motion to add alter ego allegations against defendants Kerns, Sierra Alta Terra and Almanor Lakefront Village, LLC, is granted, as the court finds there is no prejudice to the defendants. With regard to the additional claims against defendant Suburban, the court **denies** the motion to amend, as the court finds it is untimely, and would prejudice the defendants.
