Case No. CV20-00161 Hill, Adriane v Hat Creek Constructions & Materials

Tentative Ruling: Defendant California Department of Transportation (hereinafter referred to as "Caltrans") has filed a general demurrer to the Complaint and the second cause of action of the Complaint. Defendant maintains that the demurrer to that cause of action should be granted without leave to amend on the basis that (1) Plaintiff has failed to allege the presentation and rejection of a claim per the Tort Claims Act; (2) Government Code 815 prohibits public entity liability for common law negligence and (3) the Second Cause of Action fails to identify a statutory basis for public entity liability under Government Code §§ 810 and 815.

Defendant Caltrans also filed an Objection to Evidence submitted by Plaintiff in support of Opposition to Demurrer. In deciding a demurrer, there is no question that it is well established that a demurrer tests the sufficiency of the Complaint on its face, or upon any matter of which this Court can take judicial notice. Code of Civil Procedure §430.30(a); Blank v. Kirwan (1985) 39 Cal 3d 311, 318. Moreover, it has long been held that a court cannot consider extrinsic evidence or facts which have not been alleged in this Complaint or nor matters which are not proper subjects of judicial notice. Rea v. Blue Shield of Cal. (1994) 226 CA4th 1209, 1223.) Therefore, this Court sustains the Defendant's Objections to facts stated in the Declaration of Zachariah D. Hanson in deciding whether the Defendant's Demurrer is to be sustained. However, this Court can consider the facts alleged in that Declaration in deciding whether the Plaintiff is entitled to leave to amend if the demurrer is sustained. Physicians Committee for Responsible Medicine v. Los Angeles Unified School District (2019) 43 Cal5th 175, 193. Therefore, as to the Court's determination of the issue of whether leave to amend is appropriate, the Objections are overruled and this Court will consider the evidence set forth in the Hanson Declaration to decide whether to grant leave to amend.

The Court has reviewed the factual allegations set forth in the Complaint as a whole, and those set forth in the second cause of action. The Court does not consider any factual allegations set forth in the declaration of Plaintiff's counsel nor in Plaintiff's Memorandum of Points and Authorities filed in opposition to the Demurrer. The Court sustains Defendant Caltrans Demurrer to the Complaint on the grounds that it fails to state facts alleging the claim presentation against a public entity, fails to state facts sufficient to constitute a cause of action against Defendant Caltrans for common law negligence, and further that in this Complaint, Plaintiff has failed to plead with particularity a statutory cause of action against Caltrans, a public entity.

As to the question of whether Plaintiff should be granted leave to amend this initial Complaint, leave to amend is liberally allowed as a matter of fairness, and upon a showing by the Plaintiff how an amendment may cure the defects in an initial complaint. *Thornton v. California Unemployment Ins. Appeals Bd.* (2012) 204 CA4th 1403, 1423. The Court has reviewed the Declaration of Zachariah D. Hanson and the Memorandum of Points and Authorities submitted by the parties on this issue. This Court does grant Plaintiff Adriane Hill leave to amend this Complaint and any amended complaint is to be filed within twenty days of notice of entry of this Court's Order sustaining Defendant's Demurrer.

Defendant Caltrans is to prepare the proposed order sustaining the Defendant Caltrans Demurrer to the Complaint.
