# Case No. CV21-00016 California State Grange v Taylorsville Community Grange No. 439

Tentative Ruling: Defendant Taylorsville Community Grange et al., (hereinafter referred to as "Taylorsville Hall") has brought the Motion to Strike the portions of Plaintiff California State Grange's (hereinafter referred to as "State Grange") Amended Complaint referring to a claim for punitive damages in paragraph 102 and item 13 of the Prayer for relief.

### Motion to strike portions of the Complaint and prayer relating to punitive damages.

A court must grant a motion to strike a plaintiff's claim for punitive damages if the complaint fails to set forth the elements stated in the general punitive damage statute *Civil Code* §3294; *Turman v. Turning Point of Cent Cal., Inc.* (2010) 191 CA4th 53, 63-64.) Per §3294(c) (1), the element of malice "means conduct which is intended by the defendant to cause injury to the plaintiff or despicable conduct which is carried on by the defendant with a willful and conscious disregard of the rights or safety of others" or (2) the element of oppression "means despicable conduct that subjects a person to cruel and unjust hardship in conscious disregard of that person's rights." *Civil Code* §3294(c)(3) also authorizes punitive damages for fraud. Lastly, it has long been held those facts warranting punitive damages must be alleged in the pleading to

put a defendant on notice as to the basis of the claim for punitive damages. *Grieves v. Superior Court* (1984) 157 CA3d 159, 166; *Blegen v. Superior Court* (1981) 125 CA3d 959, 963.

The Court has reviewed this 21 page Verified Complaint which has laid out in painstaking detail the allegations regarding conduct of Defendant Taylorsville Hall and its representatives. In those allegations, this Court does not find sufficient factual allegations of malice, oppression, or fraud as required by *Civil Code §3294*.

Accordingly, Defendant Taylorsville Hall's Motion to Strike Punitive Damages is granted with leave to amend. Plaintiff is to file any amended pleading within 15 days of notice of entry of this Order. Defendants' counsel is to prepare the proposed Order incorporating this Court's Ruling pursuant to Rule of Court 1312.
